How long we keep personal data

Sharing of personal data with third parties

Hofstede Villetta does not sell your information to third parties and will only provide it if this is necessary for the implementation of our agreement with you or to comply with a legal obligation. With companies that process your data in our order, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Hofstede Villetta remains responsible for these processes.

Hofstede Villetta provides data to Recranet (booking system) in connection with bookings and Mollie in connection with payments of these bookings.

Cookies, or similar techniques, that we use

Hofstede Villetta uses only technical and functional cookies. And analytical cookies that do not infringe on your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferred settings. We can also use this to optimize our website. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information that was previously saved via the settings of your browser.

View, modify or delete data

You have the right to view, correct or delete your personal data. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.
